FEEDING YOUR LAWN WITH ORGANICS

Jonathan Green Organic Lawn Food promotes a lush green lawn. These homogenous, easy-to-spread granules, can be used on established and newly seeded lawns or when sodding. Use in spring, summer or fall.

The organic approach to lawn care takes time, be patient, since nature needs time to break down nutrients. Children and pets may re-enter the lawn area immediately after application.

CONTROLLING WEEDS NATURALLY:

Weeds will naturally be choked out as the turf thickens. Use Black Beauty grass seed, follow a balanced fertilizing program and raise mowing height to 3" to provide the best defense against weeds.

GRASS CLIPPINGS:

Grass clippings contain nutrients and water that are beneficial to the lawn. Do not remove clippings unless they clump on the lawn, grass clumps can smother desirable grass. To prevent clumping of grass on the lawn, keep mower blades sharp and be sure not to cut off more than 1/3 of the grass leaf at any one time. Use of a mulching mower aids in returning clippings to the soil.

DIRECTIONS FOR USE

Jonathan Green Organic Lawn Food is ideal for use on established lawns, newly seeded lawns and when sodding. This product can be applied to all cool-season or warm-season grasses. Product should be applied to a dry lawn that has been recently mowed. It is best to water product in after application for 15 minutes, however, this is not necessary. About 1 inch of water per week is sufficient between rainfall and irrigation for best lawn growth throughout the growing season.

HOW MUCH TO APPLY

ESTABLISHED LAWNS:

Apply bag according to spreader chart. Water in if possible for 15 minutes.

NEWLY SEEDED LAWNS - THIN LAWNS - SODDING:

Apply bag according to the spreader chart. To improve results, aerate before application or applying grass seed. Water in if possible for 15 minutes.

SPREADER SETTINGS

The following settings are approximate. An accurate calculation can be made by application to 1,000 sq. ft. and adjusting spreader opening to apply 3.10 lbs. per 1,000 sq. ft. Settings are based on an average walking speed. Reduce setting for slower speed; raise setting for higher speed. Check your spreader on 250 square feet and adjust to apply at the rate of .78 lb. per 250 square feet. Sweep (do not wash) all fertilizer materials from surfaces immediately after application, because certain fertilizer ingredients can cause permanent stains. Wash out spreader after each use and allow it to dry thoroughly. Treat any exposed metal spreader areas with oil to reduce corrosion.

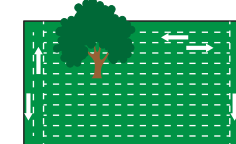

USAGE TIPS

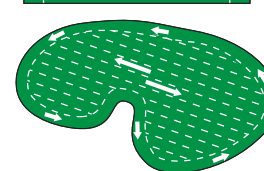
For rectangular lawns

Apply two header strips across each end for a turning area. Then apply back and forth in the longest direction.



For irregular-shaped lawns

Apply a header strip around the entire lawn for a turning area, then apply back and forth.



- Note:** For rotary spreaders, each pass should be within 10 feet of each other to ensure an overlap.
- Do not leave spreader open when making turns.
 - For best results, do not apply on a windy day.
 - Swath will vary due to weather conditions, product used and walking speed.
 - To determine how much coverage you need, multiply the length of your lawn by its width. This equals your total square footage. Deduct any non-lawn areas (house, gardens, walkways, etc.).

CAUTION

Store product in a cool, dry place out of the reach of children and pets. Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn or garden and sweep any product that lands on the driveway, sidewalk or street back onto your lawn or garden. Also, sweep fertilizer off concrete surfaces to avoid staining.
